# Civil Rights Medicaid Scorecard

## Introduction

At the beginning of the Covid-19 pandemic and ensuing public health emergency (PHE), the federal government enacted new requirements around Medicaid, most notably a requirement that recipients of Medicaid be continuously enrolled for the duration of the PHE. The PHE ended in early 2023, and as a result states across the country moved to disenroll or “unwind” their Medicaid rolls of people who are deemed ineligible.

This report analyzes the status of Medicaid unwinding in all 50 states and Washington, DC, how many residents of each state are being disenrolled for “procedural reasons” (disenrollments that occur for mainly erroneous reasons like the state not having an enrollee’s updated contact information or computer system issues), along with information on which states have expanded Medicaid access to residents as permitted by the Affordable Care Act. This report seeks to evaluate each state and its governors on how much is being done to protect healthcare access for the most vulnerable residents of each state.

## Scorecard Methodology

This scorecard uses each state’s disenrollment status, Medicaid expansion status, and procedural disenrollment rate to determine passing, incomplete, and failing grades. Procedural disenrollment rate was calculated using the share of people disenrolled for "procedural reasons" compared to the share disenrolled because they were deemed ineligible in each state. The scorecard also considers that the federal government has required several states to pause their disenrollment process because of excessive procedural disenrollment. With these data, the grading criteria below will be used to assess state performance:
