Preparing a federal tax return	<p>Find <a href="#">free options</a> on IRS.gov or in your community for those who qualify:</p> <ul style="list-style-type: none"><li>Go to <a href="https://irs.gov/FreeFile">IRS.gov/FreeFile</a> to find brand name software to prepare and e-file your return for free</li><li>Go to <a href="https://irs.gov/VITA">IRS.gov/VITA</a> to find free tax help. Select Free Tax Help on the <a href="#">IRS2Go</a> app, or call 1-800-906-9887 to find the nearest location for free tax preparation. The military community may also use <a href="#">MilTax</a>.</li><li>Go to <a href="https://irs.gov/TCE">IRS.gov/TCE</a> for free help with your taxes, or call 1-888-227-7669 to find the nearest location for free tax preparation</li><li>Check to see if you're eligible for <a href="#">IRS Direct File</a>, and file online directly with IRS for free.</li><li>Use <a href="#">Direct Deposit</a> when filing your return for a quicker refund. It's fast and safe.</li></ul>
