What is an Executive Order?



Executive orders (EOs) give presidents the power to enact policy that bypasses Congress WHAT IS AN EXECUTIVE ORDER?

Executive order: an official document signed by the president declaring government policy

• The purpose of an executive order is to give instructions to government agencies and departments about how to execute and enforce legislation

F • In recent years executive orders have been used more broadly to instruct agencies and departments how to operate in certain policy areas

Checks by other government branches



Congress may pass legislation revoking or modifying the powers it gave a president through previous legislation If vetoed by the president, Congress can override with 2/3 majority vote in both chambers
