## Creating an IRS ID.me Account

CONTINUING TO THE INTERNAL REVENUE SERVICE To protect your identity and information from fraudulent actors, your authentication and transactionrelated data (the information related to your ID.me account and identity verification) will be shared with the IRS. This helps ensure that it is really you interacting with the website and not someone pretending to be you. This information includes transaction-related data like the following: • Prior sign-ins using your ID.me account (but the names of the websites you access would not be disclosed) • Multi-factor authentication methods (e.g., text message or push notification) The status of your verification (e.g., what steps you have or have not completed; partially entered information)

If you choose not to continue, you will not be able to use your ID.me account to access IRS.
